Priority for public transit over car traffic

Need of reconsidering the "capacity-oriented" approaches Prioritizing URBAN FORM and FORM OF PUBLIC SPACES over the traffic capacity


Grunwaldzka Avenue case study

Site important for local communites – both local and city-wide


Need of integrating the development processes with transformation of the transportation system
